

EXECUTIVE SUMMARY | APRIL 2014

April has been another busy month of ACCESS for ELLs 2.0 field testing, with a total of approximately 6,000 students completing the 2014 field test by the end of the month. WIDA is grateful to all educators and district staff who have participated as their hard work and commitment to supporting our initiatives has gotten us this far.

Out of the 20,000 students needed for the field test, we are still a long way from obtaining the necessary number of students to produce a psychometrically sound assessment. However, there is still time to participate, since the 2014 field test will continue through June 30th. The **WIDA Executive Committee/ASSETS Steering Committee** held a meeting in Chicago, April 9th-10th Key topics of the meeting included:

- Consortium governance: recommendations for how to best utilize the WIDA Executive Committee and ASSETS Steering Committee and collaborating with SEAs to meet the needs of a growing consortium
- Updates on ACCESS for ELLs 2.0 test development, field testing, and recruitment efforts
- Proposals for accessibility and accommodations guidelines
- Rollout of communications and transition planning

All **ASSETS subcommittees** are preparing topics for discussion and decisions at the June Board Meeting.

Cross-Consortia Collaboration – New Communications Tools for Districts!

- All six consortia provided input for a new website and tool created by the State Educational
 Technology Directors Association (SETDA). The newly released Guide to Technology Requirements
 Tool (http://gtr.setda.org/) allows educators to filter by state and consortia to determine the minimum
 and recommended technical requirements for any of the six multi-state consortia assessments.
- The K-12 Testing Center at ETS released the 2014 version of <u>"Coming Together to Increase Achievement"</u>, a free publication on their website that outlines important information about the use and timelines for all six multi-state testing consortia.

GENERAL TEST DEVELOPMENT

In addition to the multi-partner support of the 2014 field test, in April, the Center for Applied Linguistics (CAL) continued new Listening item development and held discussions with WIDA on plans for the interim assessments. UCLA researchers analyzed data related to the Dynamic Language Learning Progressions and presented on their progress at several national conferences. UCLA researchers and WIDA's Teaching and Learning team held ongoing discussions about professional development modules for the new progressions.

1.0 ASSETS Consortium Management

2.0 Create an online EL proficiency assessment system aligned with EL proficiency standards that corresponds to college and career ready standards, including:

- Annual summative assessment
 - Continued to field test 2014 Speaking, Reading, and Writing items and to plan for 2015 test
 - Held discussions regarding upcoming production and item transfer plans for the 2015 field test
 - Continued listening item development
- · On-demand screener
 - Field tested computerized screener items, alongside summative items
- Interim assessments
 - Held meetings to discuss innovative design possibilities and how to increase the utility of the Interim assessments for teachers
 - Continued progress on Framework Document that CAL will share at the June Board Meeting
- Formative assessment resources Dynamic Language Learning Progressions
 - Continued data analysis and presented and national conferences
 - UCLA and WIDA collaborated on professional development modules that are being developed

3.0 Create foundations for technology-based training program for scorers

 Held multi-partner discussions about plans for the technology-based training program for scorers. The new program will be available in 2015.

4.0 Create professional development and outreach materials

 Posted multiple communications resources to the ASSETS website to help educators stay informed of field test plans and strategies to prepare for the operational test

5.0 Evaluate the technical quality, validity, and reliability of the assessments and the effectiveness of the professional development
